1. General provisions

procedure of protecting personal data;

• your rights with regard to personal data provided to us, in particular rectification of the collected information by you and the procedure of erasing such information;

• other provisions on personal data.

3. Purpose of collection, procedure of collection, use and processing of personal data

UkrAgroConsult only collects personal information if you voluntarily submitted it or clearly expressed your consent to its use, and only for the following purposes:

- complying with legal / tax obligations regarding applicable laws

UkrAgroConsult collects the following personal data from you:

1. when you are on our website ukragroconsult.com;

• technical information such as your IP address, browser type and operating system, referring/exit pages, pages viewed, access dates;

- 2. when you create your account:
- contact details such as email, last and first name;
- 3. when you ask for a product information:
- contact details such as email, last and first name, phone number, company name;
- 4. when you purchase a product of UkrAgroConsult:

• company related information such as company full name, industry, phone number, email address, country, payment currency, legal address, postal address;

• preferences information such as browsing & order history, marketing preferences.
